WHO SHOULD ATTEND?

This certification program is for the certification of laboratory testing personnel and will include **both** the ACI Level I Aggregate Testing Technician, **and** the ACI Level 1 Strength Testing Technician exams. These exams will be offered to obtain the ACI Concrete Laboratory Testing Technician Level One (1) Certification.

COURSE DATES:

Session 1: (Review) August 1st, 2020 - 8:00 a.m. – 12:00 p.m.

Session 1: (Exam) August 8th, 2020 – 8:00 a.m. – 12:00 p.m.

Session 2: (Review) August 22nd, 2020 - 8:00 a.m. – 12:00 p.m.

Session 2: (Exam) August 29th, 2020 – 8:00 a.m. – 12:00 p.m.

COURSE CONTENT:

Both the written and the performance exams for the aggregate testing and strength testing will be given on the same day. The written exam for the Strength Testing is a one (1) hour closed book exam, and the Aggregates it is a two (2) hour open book exam. Please refer to the ACI International website for additional details for these two certification programs.

Please note: this program will **not** include any review on the written portions but will offer a hands-on review of the applicable ASTM Specifications for the aggregate and strength practical test.

PPE REQUIREMENT:

Individuals are required to wear proper PPE to the review and examination sessions.

Proper PPE includes: safety glasses; gloves; safety work shoes (steel toe preferred). No flip flops, crocs, tennis shoes, dress shoes, etc.

Not having the proper foot attire could result in the registrant not being allowed to take the practical test.

COVID PROTOCOLS:

- All the examinees must enter through the east parking lot door only*. **Do not enter through the main entrance.** (*The east parking lot can be accessed from Commerce Parkway via Chagrin Blvd or Green Road.)

- Examinees are required to fill out the health screening form, have their temperature taken & answer the questions asked of them regarding their health.

- All examinees **must wear masks, disposable gloves and the other usual PPE at all times.** They can bring their own masks if they like. External supplemental examiners must follow BASF protocols.

****As an examinee for NE Ohio ACI Chapter August 2020 Certification session, I have read and understand the above protocols and guidelines in place at BASF Beachwood facility. I agree to abide by these protocols and understand that if I do not agree to these protocols, I will not be allowed entrance into the facility and asked to leave. While in the facility, if I am caught without a mask or gloves, I will be escorted out of the facility. If this occurs on the test date, the I will be escorted out of the facility and the test will be voided and will have to wait until November to register and submit payment again.****
